Dear Sirs,

With reference to the above, it is to inform you that subsequent to the factory inspection carried out by M/s. Intertek Testing Services India Pvt. Ltd., Mumbai on 08/11/2005, for your factory located at 29, Rajasthan Udyog Nagar, GT Karnal Road, New Delhi; it is decided to enroll your firm/organization as "New Approved Vendor" for manufacture of following items only.

1. 1100 V PVC insulated cables conforming to IS : 1554 (Part-I): 1988.
2. 1100 V XLPE insulated cables conforming to IS : 7098 (Part-I): 1988.

The above approval is subject to the following conditions.

1. The registration shall be applicable to all the companies of former Gujarat Electricity Board i.e. Gujarat Urja Vikas Nigam Limited (GUVNL), Gujarat State Electricity Corporation Limited (GSECL), Gujarat Energy Transmission Corporation Limited (GETCO), Madhya Gujarat Vij Company Limited (MGVCL), Uttar Gujarat Vij Company Limited (UGVCL), Dakshin Gujarat Vij Company Limited (DGVCL) and Paschim Gujarat Vij Company Limited.
2. The registration is subject to having valid license for documents related to manufacture / supply of material. Please note that it should be renewed sufficiently in advance before the expiry of valid documents submitted by you and will have to submit with the tender documents.
3. The registration will not apply to any of your branches/offices.
4. The registration on the approved list does not guarantee the award of contracts.
5. If the performance will be found unsatisfactory by any of the company mentioned at Sr. no. 1, the rights are reserved to delete your name even before the expiry of the registration period.
6. You should promptly advise all the companies for any change in your address of office, factory partnership deed or any Articles of Association of your concern, telephone number etc. since your registration.

7. The factory inspection will be conducted every two years.
8. If you have not manufactured the above items, for which your firm is registered, all the companies reserve the right to reject your tender.

However, please note that your firm is not enrolled as a approved vendor for manufacturing of following items as you have failed to furnish supporting documents.

1. BIS License (IS: 694: 1990) for 1100, PVC Insulated cables.

This registration is valid for the period of 5 years from the date of issue of this letter. From now onward, you can participate in the tenders invited by all the companies mentioned at sr. No. 1, under the category of item / items for which your firm / organization is registered. However, with this registration, you will not be exempted from paying of EMD/SD and tender document fees etc. applicable as per tender conditions.

It is also desirable that all its suppliers should possess ISO 9002 / 9001 Certification and as such we request you to initiate the actions to obtain above certification. The companies who posses ISO 9002 / 9001 Certification will be given preference.
